

### **Completing Field Placement in a student's place of employment:**

- Students wishing to use their field placement as their placement in the Agency of their Employment will have to complete the form **"Request for Field Placement in Agency of Employment"**. (see attached)
- The place of employment must be a licensed child care operating under the C.C.E.Y.A.
- The student and the Employee's Agency will have to determine how to handle the placement and how the placement will be accomplished to achieve the learning outcomes and placement hours. Both student and Agency will have to discuss whether the student will be released from their full time job to complete placement or whether all hours in placement will be above and beyond normal work hours or a combination of both or other alternatives.
- During the hours designated as placement hours, the student must be supervised by a RECE or equivalent.
- The student cannot be an owner/operator of the program or be in a supervisory position of the staff member who will evaluate them or be a member of the owner/operator's family. The Seneca Field Placement Faculty will determine if the placement constitutes a conflict of interest. In that case the student would need to find a different placement
- **Placement Supervisor** and the student must fill out the form below and return it to the Seneca Field Placement Supervisor.

**If at any time the Seneca faculty or Coordinator determine that the student's ability to meet the learning outcomes of the specific subject are jeopardized by completing placement in the student's place of employment, then the student can be removed from the placement. An endeavor to find another placement location will be made. This will also apply if it is determined that the ethics and principles of the ECE Seneca course are compromised: i.e. the student is not being evaluated objectively by the Host Teacher or the required number of placement hours are not being accurately recorded.**
